The fee for such representation is to be determined periodically based on usual hourly charges and other criteria for legal fees, plus out-of-pocket expenses. The duration of the agreement is indefinite.

The Registrant's activities will consist of the representation of the foreign principal with appropriate members of Congress, Congressional staff and Executive Branch officials.
