
Dear Bob,

The Federal Department of Foreign Affairs has informed me that the Federal Council has decided, on August 26, 1981, to extend for another three years i.e. from January 1, 1982 to December 31, 1984, the agreement under which this Embassy retains your firm's services, as outlined in the exchange of letters of June 11 and June 25, 1970.
