

Dear Pierre:

I am writing to confirm our arrangement concerning the legal advice you have requested with respect to certain aspects of U.S. trade law and policy.

We will perform this work in accordance with our usual practice of basing our fees on the amount of time reasonably required to perform the work. Persons working on the project will keep careful records of the time they spend and the work performed, and at the end of each month I will receive a computer printout reflecting this information and calculating a charge based on the standard rates established for each person's time.
