We understand from the foreign principal that Thomson-CSF is majority-owned by Thomson S.A., a nationalized company, which is 100 per cent owned by the French government. We understand that a minority interest in Thomson-CSF is represented by shares publicly traded in France, and, on information and belief, is held by foreign principals. Financing of Thomson-CSF is partly through capital increases from its majority shareholder, Thomson S.A. which is, in turn, financed through capital increases from its shareholder, the government of France.


