The Registrant has been retained to render advice on U.S. laws, regulations and policies relating to and on the feasibility of methods for obtaining financing for housing in Israel and for the development of agricultural projects in the United States and elsewhere. The Registrant will also work with the foreign principal to raise funds in the United States for these ventures. The fee for such representation is to be determined periodically based on usual hourly charges and other criteria for legal fees, plus out-of-pocket expenses. The duration of the agreement is indefinite.

5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

Initially the Registrant agreed to engage in activities on behalf of the foreign principal that did not require registration under the Act. The Registrant has provided and will provide legal advice to the foreign principal with respect to U.S. laws, regulations and policies relating to and on the feasibility of methods for obtaining financing for housing in Israel and for the development of agricultural projects in the United States and elsewhere. More recently, the Registrant has orally agreed to work out various financing arrangements which may involve different agencies of the federal government. The Registrant is registering because these latter activities may require such registration.

6. Will the activities on behalf of the above foreign principal include political activities as defined in Section 1(o) of the Act? ^{1/} Yes No

If yes, describe all such political activities indicating, among other things, the relations, interests or policies to be influenced together with the means to be employed to achieve this purpose.

The Registrant may engage in political activities on behalf of the foreign principal.
