DEAR DR. HARAMBILLET:

THIS TELEX WILL CONFIRM THAT ARNOLD AND PORTER HAVE UNDERTAKEN TO REPRESENT EMPRESA NACIONAL DE MINERIA ("ENAMI") IN CONNECTION WITH THE ABOVE PROCEEDING BEFORE THE UNITED STATES INTERNATIONAL TRADE COMMISSION IN WASHINGTON, D.C. ON BEHALF OF ENAMI, WE SHALL FILE A NOTICE OF INTENTION TO PARTICIPATE IN THE PROCEEDING ON WEDNESDAY, MARCH 7, 1984.

THERE FOLLOWS THE TEXT OF OUR STANDARD RETAINER LETTER, THE TERMS OF WHICH WE REQUEST YOU TO CONFIRM BY TELEX AT YOUR EARLY CONVENIENCE:

"THIS WILL CONFIRM THE BASIS UPON WHICH EMPRESA NACIONAL DE MINERIA ("ENAMI") HAS RETAINED OUR FIRM.

"IT HAS BEEN AGREED THAT ARNOLD AND PORTER WILL REPRESENT ENAMI IN CONNECTION WITH THE PENDING INVESTIGATION OF COPPER IMPORTS UNDER SECTION 201 OF THE TRADE ACT OF 1974.

"IT HAS BEEN AGREED THAT ENAMI WILL PAY ARNOLD AND PORTER A FEE FOR ITS SERVICES WITH RESPECT TO THIS MATTER. THIS FEE WILL BE IN ACCORDANCE WITH THE USUAL AND CUSTOMARY CHARGES WE MAKE FOR MATTERS OF THIS NATURE, PRIMARILY BASED UPON OUR USUAL TIME CHARGES FOR PROFESSIONAL, PARAPROFESSIONAL AND OTHER DIRECT HOURS DEVOTED TO THESE SERVICES. STATEMENTS FOR OUR SERVICES WILL BE SENT TO YOU ON A MONTHLY BASIS.

"IT IS ALSO UNDERSTOOD THAT, IN ADDITION TO THE AMOUNTS TO BE PAID US FOR OUR SERVICES, ENAMI WILL REIMBURSE ARNOLD AND PORTER FOR OUT-OF-POCKET EXPENSES INCURRED ON BEHALF OF ENAMI, INCLUDING SUCH ITEMS AS TRAVEL EXPENDITURES AND LIVING EXPENSE WHEN OUT OF TOWN, TAXI FARES, LONG-DISTANCE TOLLS, PRINTING, DUPLICATING AND OTHER REPRODUCTION COSTS AND CHARGES, AND THE LIKE. STATEMENTS FOR THESE DISBURSEMENTS WILL BE SENT TO YOU ON A MONTHLY BASIS."

AS YOU KNOW, THIS FIRM ALREADY IS REPRESENTING CORPORACION DEL COBRE - CHILE ("CODELCO") IN THE ABOVE PROCEEDING. WE ARE NOT AWARE OF ANY CONFLICT OF FACT, ISSUES, OR LAW WHICH WOULD PRECLUDE US FROM REPRESENTING BOTH CODELCO AND ENAMI IN THIS PROCEEDING. HOWEVER, IF ANY SUCH CONFLICT ARISES, WE WILL PROMPTLY NOTIFY YOU TO THAT EFFECT. IN THE EVENT OF A CONFLICT, WE MIGHT BE OBLIGED TO WITHDRAW FROM REPRESENTATION OF ENAMI IN FAVOR OF CODELCO. HOWEVER, WE EMPHASIZE THAT WE ARE NOT AWARE OF ANY SUCH CONFLICT AND DO NOT BELIEVE THAT ANY SUCH CONFLICT IS LIKELY TO ARISE.

WE AWAIT ARRIVAL OF SHIPMENT OF MATERIALS FROM YOU AS DESCRIBED IN OUR TELEPHONE CONVERSATION OF MARCH 2.
