

The Registrant will render advice on U.S. and international regulations, laws and policies and will represent the foreign principal in connection with issues relating to U.S.-Chilean economic, financial and trade matters. The fee for such representation is to be determined periodically based on usual hourly charges for legal fees, plus out-of-pocket expenses. The duration of the agreement is indefinite.

The Registrant will render advice on U.S. and international regulations, laws and policies and will represent the foreign principal in connection with U.S.-Chilean economic, financial and trade matters.
