ITEM II - During the six months ending March 27, 1976 the Alpine Tourist Commission maintained a travel industry and consumer information center in New York which (a) represented the ATC in press and trade liaison at the ASTA Convention in Rio; (b) represented ATC in trade liaison at the ASTA Midwest Conference in January in Minneapolis and the ASTA Southern Conference in February in Memphis; (c) fulfilled approximately 100 requests for Alpine information from prospective travelers; (d) developed, through contact and correspondence with 150 American tour wholesalers, the text for inclusion in the 1976 anthology of package tours visiting 2 or more Alpine countries.
