The Alpine Tourist Commission was founded in 1954 for the purpose of a joint promotion campaign for travel to the Alpine countries. Activities consist mainly of a joint advertising campaign in a number of newspapers in the U.S. The Commission also conducts limited publicity; such as, sending news releases to travel agents, newspapers, airlines, - on a non-commercial basis. There was no film distribution during these six months.

For the purpose of travel promotion a two year contest for automobile travel to the Alps is conducted. Attached please find copies of the control book issued as well as descriptive folders. A poster is distributed to travel agents.

¹The term "foreign principal" includes, in addition to those defined in section 1(b) of the Act, an individual or organization any of whose activities are directly or indirectly supervised, directed, controlled, financed, or subsidized in whole or in major part by a foreign government, foreign political party, foreign organization or foreign individual. (See Rule 100(a)(9)).
