AMENDMENT NO. 1

TO

AGREEMENT

BETWEEN

THE ROYAL GOVERNMENT OF AFGHANISTAN

AND

ROBERT R. NATHAN ASSOCIATES, INC.

THIS AMENDMENT, entered into as of the 1st day of June, 1967, between the Royal Government of Afghanistan (hereinafter referred to as "Government"), and Robert R. Nathan Associates, Inc., a corporation duly organized and existing under the laws of the State of Delaware (hereinafter referred to as "Contractor"), with its principal offices located at 1218 Sixteenth Street, N.W., Washington, D.C. 20036,

WITNESSETH THAT:

WHEREAS, the parties hereto entered into an Agreement effective the 22nd day of July, 1965, more particularly identified as Agreement AID/nesa-186-CC, and

WHEREAS, the parties now desire to amend said Agreement for the purpose of providing additional advisory services for another term of approximately two years, and

WHEREAS, the Contractor has or will enter into a superseding contract to its existing contract, identified as Contract AID/nesa-186(1), with the Government of the United States of America, for the purpose of financing the services provided hereunder;

NOW, THEREFORE, the parties hereto mutually agree that said Agreement AID/nesa-186-CC shall be and is hereby amended as follows:

1. Change Article I-A-3e to read "Article I-A-3f".
2. Add the following new paragraph as Article I-A-3e:
"e. Advise and assist the Government in the improvement of the statistical services essential for effective economic planning and plan implementation. This assistance will include planning surveys, data processing, preparation of statistical reports and staff training."
3. Delete Article I-B-2 in its entirety and substitute the following:

"2. Contractor shall provide, for work in Afghanistan, employees for the positions designated below:

a. Economic Advisory Team

Position

- (1) Chief Economist - Chief of Party

responsible for operation and administration of team in Afghanistan and authorized field representative of Contractor

(2) Financial Economist - Qualified in monetary, credit, and foreign exchange areas.

(3) Industrial Economist - Qualified in field of manufacturing, economic planning and policy in mining and power areas.

(4) Agricultural Economist - Qualified in economic problems concerned with agricultural planning, programing, and policy.

(5) Economic Statistician - Qualified in statistical survey and census procedures, national income accounting and administration of statistical services.

(6) Administrative Assistant

b. Short Term Technicians

Specialists in such fields as banking, balance of payments, wage and price policy or tariff policy, as required.

c. Local Hire Personnel (Afghan subjects or U. S. citizens)

(1) Secretary - to the extent authorized in writing by the Mission Director or his designee.

(2) Translators - to the extent approved by
the Mission Director or his designee."

Except as expressly hereby amended, said Agreement AID/nesa-
186-CC is in all respects ratified, confirmed and continued in full
force and effect in accordance with its terms.
