On their behalf we provided general service and information to tourist trade and the traveling public, including distribution of booklets, literature and display matter, in addition to posters and maps all relating to Bermuda, and occasional delivery of speeches or lectures, discussions and radio, television broadcasts and appearances, designed to attract tourist trade in, and travel to, Bermuda. We also distribute press releases all relating to Bermuda to travel editors, writers and trade magazines.

On September 9,10,13,14,15, 16,17,21,22,23,24,1971 gave film presentation and reception for members of travel agencies, carriers (airlines and steamships), press and trade press in Hempstead, N.Y., Hartford, Conn., Washington, D.C., New York, N.Y., Morristown, N.J., Boston, Mass., Cleveland, Ohio, Detroit, Mich., Chicago, Ill, & Philadelphia, Pa.

On Oct. 14, 1971 David B. Mitchell, Asst. Mgr-Sales, presented our film "Bermuda the Island Nobody Wanted" and spoke to 35 members of the general public in Ramsay High School, Ramsay, N.J.

On Dec. 14, 1971 David B. Mitchell and Charles H. Webb, Asst. Mgrs.-Sales, spoke to and presented film program to 40 members of the Norwalk Community College, Norwalk, Conn., concerning College Weeks in Bermuda.

Bermuda literature was dissiminated to each of the above.

¹The term "foreign principal" includes, in addition to those defined in section 1(b) of the Act, an individual or organization any of whose activities are directly or indirectly supervised, directed, controlled, financed, or subsidized in whole or in major part by a foreign government, foreign political party, foreign organization or foreign individual. (See Rule 100(a)(9)).
