1. Expenditures are in conjunction with operations of SABENA Belgian World Airlines. An allocation of expenses, other than for advertising & publicity & related activities as indicated under Item 14(a), attributed to the Tourist Office is made in Belgium, but registrant does not have details other than mailing costs approximated at \$250 monthly, and salary of about \$690 monthly paid to Mrs de Bary of our Information Desk.
2. Our advertising agency (Picard Advertising, Inc., 964, Third Av., NYC NY) handle only procurement of space & the mechanical aspects of placing ads. During this period payments to them were approx. \$3,958.61 as per copies of invoices herewith*(An ad was placed directly in the Belgian American Trade Directory, NYC NY \$600.-) Enclosures A.
