During this period Mr. Zagaris assisted on an appeal of a coram nobis petition brought by Mr. Hossein Alikhani, beneficial owner of Polygon Co., Ltd. in the U.S. Court of Appeals for the 11th Circuit, appealing his conviction of a violation of the Libyan sanctions under the International Economic Emergency Powers Act (IEEPA). Mr. Zagaris also communicated with the International Human Rights Law Clinic, Washington College of Law, American University, concerning a petition brought on behalf of Mr. Alikhani and pending in the Inter-American Commission on Human Rights.


