WASHINGTON – Members of Congress and friends of Kurdistan celebrated Newroz, the traditional start of the New Year embraced by Kurds and others throughout the countries of the Middle East and Central Asia, in the U.S. Capitol Building, at a celebration hosted by the Kurdistan Regional Government's Representation to the United States.

"We welcome you all with rose petals to our office," Rep. Joe Wilson of South Carolina, the Republican co-chair of the Kurdish American Congressional Caucus, told the crowd. He praised the Kurdistan Region for its economic and political stability and touted it as "a great place for persons to invest."

Upon defeating Zuhak, Kawa is said to have set fire to the hillsides to celebrate the victory; and mark the freedom of the Kurdish people as spring returned to Kurdistan the next day. For this reason, as well as to signify the arrival of the season of light, the tradition of lighting bonfires in Kurdistan on Newroz continues to this day.

Qubad Talabani, KRG representative to the United States, welcomed the guests and said the combination of the photos of his homeland and the warmth of the friends gathered ensured that the start of this new spring would mark more progress and good news in Kurdistan's strong and unique relationship with the United States. "Continued political and economic development will only serve to ensure the sacrifices made by Americans in Iraq will lead to the emergence of a stable and federal Iraq, with a democratic and economically prosperous Kurdistan Region".

Erbil ranked 5th Middle East city with potential for foreign direct investment

London - UK (UK.KRG.org) - An international investment magazine has awarded Erbil fifth place in a ranking of the top Middle East cities with potential for foreign direct investment. This places Erbil ahead of Muscat and Riyadh.

FDI Magazine, a subsidiary of the Financial Times, in this month's edition, ran a feature on Middle East cities of the future, ranking cities by economic potential, infrastructure, business friendliness and FDI promotion strategy.

In the listing for cities with the most potential for FDI, the magazine gave Amman top place followed by Dubai, Manama, and Ras Al Khaimah and then Erbil. Riyadh was ranked 9th and Muscat 6th.

Bayan Sami Abdul Rahman, the KRG High Representative to the UK, said, "FDI Magazine's recognition of Erbil as a Middle East city of the future with potential for foreign direct investment confirms what many who have been doing business in Kurdistan already know - that Kurdistan and its capital are ripe for investment and ready to do business."

The Kurdistan Region is increasingly seen as the commercial gateway to Iraq and is attracting trade and investment from around the world, particularly from neighbouring countries. The region's trade with Turkey comes to about \$7.5 billion dollars a year, followed by Lebanon, Iran and the Gulf states.

The Kurdistan Board of Investment and Ministry of Trade and Industry go out of their way to ease business in Kurdistan, with the assistance of the chambers of commerce and other trade organisations. The Board of Investment estimates \$17 billion has been invested in projects ranging from cement factories to shopping malls in Kurdistan in the past five years.

European business communities are also turning to Kurdistan and there are regular trade delegations visiting the region from the UK, France, Italy, Austria, Germany and other EU countries. Erbil's international airport offers direct flights to Frankfurt, Vienna, Amman and many other destination and an increasing number of hotels in the capital make it a business friendly environment.

A trade and investment conference in London last year attracted over 600 people representing 205 companies, 60 media organisations and close to 20 diplomatic missions.

Kurdistan has also recently been listed as a favourite tourist destination. The New York Times placed the region in its top 34 places to visit and National Geographic Magazine listed it as 20.

Kurdistan's leaders tell Senators McCain and Graham American help should continue after troop withdrawal

Salahaddin, Kurdistan - Iraq (KRG.org) - President Masoud Barzani and Prime Minister Barham Salih yesterday in Erbil met US Senators John McCain and Lindsey Graham and discussed the future of Iraq's relations with the United States.

The discussions primarily focused on the political situation in Iraq and on the country's ability to maintain internal and external security after the US troop drawdown later this year.

Speaking about breaking through the political deadlock and helping to forge the new Iraqi government, President Barzani said, "The main Iraqi political factions signed a number of documents in November 2010 that concern power-sharing, partnership and other key issues." These agreements are critical to the stability and political progress in the country, he said.

The two senators commended President Barzani for his role in forming the new Iraqi government, but added that the US would greatly appreciate further efforts to help settle the stalemate in Baghdad over who will head the Ministries of Defense, Interior, and National Security.

Confirming his willingness to renew his own efforts, President Barzani said that he will focus his energy on bringing the Iraqi parties closer together to resolve the stalemate, and he reiterated that all sides remain committed to the previous agreements. However, he added that all Iraqi sides must work harder to reach an agreement on the leadership of those critical ministries so that they can address Iraq's security challenges.

In a separate meeting with the delegation, Prime Minister Salih also spoke about the US's continued assistance. He said, "The assistance of the US [after troop withdrawal] will help to maintain a stable Iraq and to develop democracy."

The delegation commented on the Kurdistan Region's strong development and stability and the positive environment that has been created for economic and commercial activity. They remarked that the region is an example of how reconstruction should proceed throughout the country.

The delegation included the Ambassador to Iraq James Jeffrey, the Commanding General of US forces in Iraq General Lloyd Austin, and other officials. Upon their arrival, the delegation was met at the airport by the Kurdistan Regional Government's Head of Foreign Relations, Minister Falah Mustafa Bakir. The President's Chief of Staff Dr. Fuad Hussein, attended the meeting with the President, and Minister Bakir, as well as members of the local US Regional Reconstruction Team, attended both of the official meetings.

The delegation visited some areas manned by the Combined Security Mechanism, in which Arabs, Kurds, and Americans operate checkpoints and conduct joint patrols in four governorates that lie between

Kurdistan Region and the rest Iraq. Nawzad Hadi, the Governor of Erbil, gave them a tour of Erbil Citadel and the bazaar.

President Barzani asks US Congressional delegation to promote economic ties

Erbil, Kurdistan - Iraq (KRG.org) - President Masoud Barzani on Friday in Salahaddin met a delegation from the US Congress to discuss political developments in Iraq, bilateral relations, and the question of America's military presence in Iraq. He also thanked them for encouraging the US Government to open an American consulate in Erbil in the near future.
