(2) MACP: Blank Rome has worked in conjunction with MACP to communicate with principals and staff of the federal government and educate them on U.S.-Moroccan relations and Morocco's commitment to securing a permanent resolution of the Western Sahara issue, with the express purpose of encouraging U.S. actions that promote Moroccan sovereignty, security, and prosperity. Blank Rome also provided strategic advice to MACP on the dynamics of U.S. foreign policy decision making and distributed information provided by MACP to its contacts in the Washington foreign policy community.
