In association with the tourist offices of New Zealand and Papua-New Guinea, programs directed to travel industry and through the travel industry, to potential travelers, presenting the travel attractions of Australia and the South Pacific. In association with international airlines and shipping lines serving Australia, jointly financed advertising campaigns featuring the travel attractions of Australia, and publicity and promotional campaigns to achieve wider exposure of Australia's travel attractions.

<sup>1</sup> The term "foreign principal" includes, in addition to those defined in section 1(b) of the Act, an individual or organization any of whose activities are directly or indirectly supervised, directed, controlled, financed, or subsidized in whole or in major part by a foreign government, foreign political party, foreign organization or foreign individual. (See Rule 100(a)(9)).


