TRAVEL PROMOTION -- By contact with representatives of the travel industry and publicity media (television, radio, newspapers and travel industry publications) and with individuals (potential travelers) in the United States; by dissemination of publicity materials to the travel industry, individuals (potential travelers) and publicity media; by placement of travel films on television; by radio interviews; by preparation of travel articles for newspapers, magazines and travel industry publications; by lectures to travel industry groups and others; and by briefing of writers and photographers going to Australia on travel assignments. In association with the international carriers serving Australia, production of material designed for the travel industry and through the travel industry for potential travelers, presenting the travel attractions of Australia and the South Pacific. In conjunction with the international carriers serving Australia, jointly financed advertising campaigns featuring the travel attractions of Australia and publicity and promotional campaigns to achieve wider exposure of Australia's travel attractions.

¹The term "foreign principal" includes, in addition to those defined in section 1(b) of the Act, an individual or organization any of whose activities are directly or indirectly supervised, directed, controlled, financed, or subsidized in whole or in major part by a foreign government, foreign political party, foreign organization or foreign individual. (See Rule 100(a)(9)).


