On behalf of the Australian Tourist Commission, the following travel promotion activities have been undertaken: contact with representatives of the travel industry and the publicity media, (i.e. TV, Radio, newspapers, and Travel Industry publications) and with individual potential travellers by placement of travel advertising on TV and Radio, by preparation of travel articles and by briefing of writers and photographers going to Australia on travel assignments. In conjunction with internat'l. carriers servicing Australia, travel trade promotion material has been produced and disseminated, which presents Australia's tourist attractions. In conjunction with these same carriers, advertising and other promotional campaigns have been undertaken to achieve a wider exposure of Australia's travel product.


