

The Registrant has rendered and will render legal advice to the foreign principal with respect to U.S. laws, regulations, policies and proposed legislation that may affect or relate to imports of pork products from Canada, arising out of the countervailing duty investigation conducted by the U.S. Department of Commerce and the International Trade Commission, and will engage in other activities as required in legal representation of the principal.
