- Describe fully the nature and method of performance of the above indicated agreement or understanding.

The Registrant will render advice on U.S. laws, regulations, and policies that may affect the foreign principal and will represent the foreign principal with respect to actions of the U.S. Government that might lead to restrictions on imports of vegetables from Mexico. The fee for such representation is to be determined periodically based on usual hourly charges and other criteria for legal fees, plus out-of-pocket expenses. The duration of the agreement is indefinite.

5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The Registrant will render advice on U.S. laws, regulations, and policies that may affect the foreign principal and will represent the foreign principal with respect to actions of the U.S. Government that might lead to restrictions on imports of vegetables from Mexico. Some of the activities of the Registrant on behalf of the foreign principal may require registration under the Act.

6. Will the activities on behalf of the above foreign principal include political activities as defined in Section 1(o) of the Act?^{1/} Yes No

If yes, describe all such political activities indicating, among other things, the relations, interests or policies to be influenced together with the means to be employed to achieve this purpose.

The Registrant's activities will include the representation of the foreign principal with various members of Congress, Congressional staff and Executive Branch officials. The purpose of such representation will be to discourage the imposition of restrictions on imports of vegetables from Mexico.
