
The Registrant has rendered and will render legal advice and assistance to the foreign principal with respect to U.S. laws, regulations and policies in connection with the efforts of the foreign principal to obtain treatment for its products under the Generalized System of Preferences and will engage in other activities as required in legal representation of the principal.
