Bolivarian Republic of Venezuela

The Registrant rendered advice to the foreign principal on U.S. laws, regulations and policies concerning government bond offerings in international financial markets and related taxation issues, the registration of debt securities with the U.S. Securities and Exchange Commission, and certain banking issues. The Registrant represented the foreign principal in connection with export/import financings, including financing from the U.S. Export-Import Bank. The Registrant rendered advice and provided services to the foreign principal with respect to the restructured Venezuelan external debt and compliance by the foreign principal with certain debt covenants. The Registrant also represented the foreign principal in an international arbitration.
