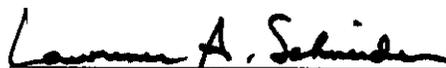

State of Israel

The Registrant rendered advice to the foreign principal with respect to various financing vehicles, and U.S. laws, regulations and policies relating to taxation, securities, banking, international trade, and economic and financial matters. The Registrant provided advice and assistance on the registration of debt securities with the U.S. Securities and Exchange Commission, and on the implementation, through USAID, of the loan guarantee program established pursuant to the Supplemental Appropriations Act of 2003. The Registrant represented the foreign principal in litigation in *John Doe, et al. v.
