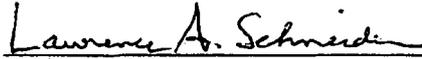

The Registrant rendered advice to the foreign principal with respect to various financing vehicles and mechanisms, international issues, U.S. court decisions, and U.S. laws, regulations and policies relating to taxation, government procurement, FDA, international trade, customs, economic and financial matters, and other international matters. The Registrant provided advice and assistance on the registration of debt securities with the U.S. Securities and Exchange Commission, and on the implementation, through USAID, of the loan guarantee program established pursuant to the Supplemental Appropriations Act, and on immigration matters. The Registrant represented the foreign principal in litigation in *Eliahu v. State of Israel* (United States District Court for the Northern District of California and the U.S. Court of Appeals for the Ninth Circuit), *Wultz v. Bank of China, Ltd.* (United States District Court for the Southern District of New York and the U.S. Court of Appeals for the Second Circuit), and *Ben-Haim v. Edri* (United States District Court for the District of New Jersey). The Registrant provided advice concerning existing, proposed and pending foreign aid, energy cooperation, and international trade-related legislation and/or agreements.
