Japan External Trade Organization (JETRO), established by a special law in Japan, is an administrative agency dedicated to promoting mutually beneficial trade and economic relations between Japan and other countries. In the United States, JETRO currently maintains offices in New York, San Francisco, Chicago, Los Angeles, Houston, and Atlanta. These offices provide information relating to the Japanese economy and business as well as U.S.-Japan economic and trade relations and engage in various activities to promote trade and direct investment between Japan and the United States. JETRO offices in the United States are believed to serve similar functions as those of the United States Trade Center (of the United States Department of Commerce) established in Japan. As the San Francisco-based office of JETRO, JETRO San Francisco provides to public officials, corporations, associations, individuals and any other interested parties information and materials relations. JETRO San Francisco also monitors the developments of U.S. economic and market conditions for JETRO.
