

ENIT - Agenzia Nazionale del Turismo is an entity wholly operated by the Administration of the Republic of Italy, with headquarters located in Rome and 26 Delegations abroad, three of which are in the U.S. The latter ones acting under the covenants of the New York Convention of International Tourism signed June 4, 1954 and signed by the Italian Government in 1957. This Delegation, aka the Italian Government Tourist Board, covering the Western U.S., is composed of one Italian Government employee holding service passport with visa status A2, regularly notified to the Department of State in Washington, D.C. through the Italian Embassy. This ENIT office is not engaged in any commercial or political activity and its sole purpose is the promotion of travel to Italy, offering services free-of-charge to the tour operators, travel agents, carriers and other travel related associations catering to Americans traveling abroad. Moreover, ENIT provides, upon request, information to the public regarding tour facilities and other attractions in Italy.
