1. BARBADOS INDUSTRIAL DEVELOPMENT

The activity of the Barbados Industrial Development Corporation has remained unchanged, i.e. generally to promote in the United States the opportunities for the location of industry in Barbados. The techniques used to achieve this end continued to be: the dissemination of industrial promotional literature in response to advertisements; business seminars and personal interviews.

2. BARBADOS TOURIST BOARD

Like the Barbados Industrial Development Corporation, the Tourist Board's activity for the period continued in its normal vein, namely encouraging tourist travel to Barbados. Advertising has been one of the major tools used, while contact with travel agents in the country was maintained.
