

Re: Engagement of Patton Boggs LLP

Your Excellency:

Patton Boggs LLP is pleased that the Government of the Republic of Cameroon has retained our firm to perform a scope of work set forth in your letter of April 30, 2004, as that scope of work is more fully described in the attachment to this letter.

To ensure that the Government of the Republic of Cameroon and we have a common understanding of the terms of our representation and to comply with the rules of professional conduct for the jurisdictions in which we practice, we enclose a statement describing the standard terms of engagement for legal services to be provided by Patton Boggs. This letter supplements and modifies the enclosed terms of engagement.

I will be principal partner responsible for the work to be performed by Patton Boggs for the Government of the Republic of Cameroon. Our work will be performed by two teams, an active team and a resource team. The active team, in addition to myself, will include partner Ronald I. Christie and associate Leah Liston. The resource team will include, among others, Thomas Hale Boggs, Jr., Rodney E. Slater, and Mark D. Cowan. We will be assisted by other partners, associates, staff attorneys, legal assistants, specialists, and in-house consultants, such as economists, all of whom will work under our supervision.

The fee for our work will be in the form of a fixed annual retainer of Four Hundred Thousand United States Dollars (US\$ 400,000), payable in quarterly installments. This fee will cover all disbursements, including travel to Yaoundé. There will be no other charges or fees. The term of this engagement will be August 1, 2004 through July 31, 2005. The retainer will be payable as follows:

- **First payment (for the period August to October 2004): \$100,000, due upon signature of this engagement letter.**
- **Second payment (for the period November to January 2005): \$100,000, due October 15, 2004.**

- Third payment (for the period February to April 2005): \$100,000, due January 15, 2004.
- Fourth payment (for the period May to July 2005): \$100,000, due April 15, 2005.


This agreement may be renewed at your option on the giving of thirty days' notice before its expiration.


