**1. The Government of Albania**

During the latter half of 2011, Registrant contacted various Congressional and Administration officials to detail the political, economic, and security policy reforms the foreign principal recently has undertaken. In Congress, Registrant concentrated on Members and staff who serve on the Senate Foreign Relations Committee, the House Foreign Affairs Committee, and the U.S. Commission on Cooperation and Security in Europe, otherwise known as the Helsinki Commission. Members on those committees have the most day-to-day involvement with issues touching on relations with the foreign principal, so Registrant focused its outreach efforts there. Registrant also advocated in the Senate and House for full funding of U.S. economic and security assistance programs affecting Southeastern Europe, as included in the FY2012 State Department/Foreign Operations Appropriations bills (S. 1601 and H.R. 3671):

**2. The Embassy of the Republic of Azerbaijan**

Registrant counseled the foreign principal on United States Congressional matters. This included monitoring issues related to the foreign principal's region. Registrant advocated in support of meetings for Embassy diplomats with Members of Congress and Congressional staff, and supported the foreign principal in developing its Congressional relations. Registrant helped monitor Congressional consideration of H.R. 2055 ("Consolidated Appropriations Act, 2012"), S. 1601 ("Department of State, Foreign Operations, and Related Programs Appropriations Act, 2012"), and affiliated measures; and advocated for report language.

**3. The Government of the Republic of Cameroon**

Registrant counseled the foreign principal on several matters involving the U.S. Government. Specifically, Registrant compiled information and analyzed the legal, regulatory, and political requirements of the Millennium Challenge Account ("MCA") Program. In addition, Registrant advised the foreign principal on how it might achieve compliance with various MCA Program requirements. Registrant also counseled the foreign principal on compliance with the African Growth and Opportunity Act, discussed with U.S. Government officials how the foreign principal might increase its benefits under the trade preference program, and advised the foreign principal on Congressional consideration of extending AGOA. Moreover, Registrant counseled the foreign principal on the legal and political ramifications of being ranked on the Tier 2 Watch List of the U.S. Department of State's Trafficking in Persons ("TIP") Report. This included developing and implementing a strategy for the foreign principal to improve its efforts to combat TIP. More broadly, Registrant monitored and advised the foreign principal of various U.S. policy developments.

**4. Embassy of the Republic of Chad**

There was no reportable activity performed on behalf of the Embassy of the Republic of Chad during this reporting period.

**5. The Embassy of the People's Republic of China**

Registrant counseled the foreign principal on United States Congressional matters. This included compiling information and analyzing the potential legal and political ramifications of passage of the "Currency Exchange Rate Oversight Reform Act of 2011" (S. 1619) and the "Currency Reform for Fair Trade Act" (H.R. 639 / S. 328), and counseling the foreign principal on how to describe its position on the issue. Registrant also helped monitor Congressional consideration of potential U.S. arms sales to Taiwan, including that related to the "Taiwan Airpower Modernization Act of 2011" (H.R. 2992 / S. 1539) and related amendments (S. Amdt. 634 to H.R. 2832 and S. Amdt. 1200 to S. 1867). In addition, Registrant advocated in support of meetings for the Ambassador with Congressional leaders. Registrant also advised the foreign principal on Congressional consideration of H.Res. 425 and potential foreign principal-related amendments thereto.

**6. China Chamber of Commerce – for Metals, Minerals and Chemicals**

There was no reportable activity performed on behalf of China Chamber of Commerce for Importers and Exporters of Metals, Minerals and Chemicals during this reporting period.

**7. China Chamber of Commerce – for Machinery & Electronics Products**

There was no reportable activity performed on behalf of China Chamber of Commerce for Importers and Exporters of Machinery and Electronic Products during this reporting period.

**8. Republic of Croatia**

There was no reportable activity performed on behalf of the Republic of Croatia during this reporting period.

**9. The Embassy of the Government of Cyprus**

Registrant counseled the foreign principal on several matters involving the U.S. Government. Registrant urged support for meetings between foreign principal officials and U.S. Government officials. Registrant counseled the foreign principal on the legal and political ramifications of being ranked on the Tier 2 Watch List of the U.S. Department of State's Trafficking in Persons ("TIP") Report. This included developing a strategy for the foreign principal to improve its efforts to combat TIP. More broadly, Registrant monitored and advised the foreign principal on various U.S. policy developments. Registrant also helped monitor Congressional consideration of the "Foreign Relations Authorization Act, Fiscal Year 2012" (H.R. 2583 / S. 1426); the Fiscal Year 2012 "Department of State, Foreign Operations, and Related Programs Appropriations Act" (S. 1601); and related legislation. This included advocating for report language concerning Cyprus. Registrant also gathered information on nominees (and potential nominees) for U.S. Ambassador to Cyprus and Turkey, and advised on questions to be asked during confirmation hearings. Registrant briefed U.S. officials and encouraged support related to certain issues including the reunification of Cyprus, foreign assistance, natural resource exploration in the Eastern Mediterranean, property rights, action against religious desecration by occupation forces, and recognition of the anniversary of Turkey's invasion of Cyprus and Cyprus National Day.

**10. The Embassy of Ecuador**

Registrant counseled the foreign principal on several matters involving the U.S. Government. First, Registrant compiled information and analysis on the legislation related to H. Res. 425. In particular, Registrant counseled the foreign principal on Congressional consideration of the Andean Trade Preferences Act (“ATPA”) and the Generalized System of Preferences. Second, Registrant helped monitor Congressional consideration of the “Foreign Relations Authorization Act, Fiscal Year 2012” (H.R. 2583) and Ambassadorial nominees Adam Namm and Roberta Jacobson. Registrant also discussed with U.S. Government officials the status of the foreign principal’s benefits under ATPA and the broader bilateral trade relationship. More generally, Registrant monitored and advised the foreign principal on various U.S. policy developments and their potential impact on the bilateral relationship.

**11. The Korea International Trade Association (KITA)**

During the latter half of 2011, Registrant advocated on behalf of the foreign principal for the passage of the Korea-United States Free Trade Agreement (KORUS FTA) and its accompanying implementing legislation, H.R. 3080. During the reporting period, Registrant contacted the Office of the United States Trade Representative and numerous Senate and House offices. Registrant discussed strategy and tactics for moving the FTA with Administration and Congressional supporters, including the Senate and House Leadership. Registrant also described the benefits of the agreement with Members and staffs from undecided Senate and House offices. As part of those duties, Registrant researched and disseminated specific information on various aspects of the FTA, as requested by individual Congressional offices.

**12. Government of Kosova**

During the second half of 2011, Registrant represented the foreign principal on multiple aspects of its relations with the U.S. Government. First, Registrant advocated in the Senate and House for full funding of U.S. economic and security assistance programs affecting Southeastern Europe, as included in the FY2012 State Department/Foreign Operations Appropriations bills (S. 1601 and H.R. 3671). Second, Registrant called on Administration and Congressional officials to support the independence and territorial integrity of the foreign principal, particularly relating to diplomatic recognition by other nations and its full sovereignty over ethnic Serb areas in the northern part of the country. Finally, Registrant supported the December visit to Washington by the President of the foreign principal, Atifete Jahjaga, including helping to set up her meetings with U.S. Government officials.

Registrant advised on various other U.S. policy developments and their potential impact on the bilateral relationship with the new government of Libya. Registrant also provided legal advice to the foreign principal in a number of areas, including immigration status for diplomats and foreign diplomats, litigation claims and judgments against the foreign principal, care for Embassy property and assets and the application of international law to the status of the foreign principal and related entities.

**14. Sovereign Military Hospitaller Order of St. John of Jerusalem of Rhodes and of Malta**

There was no reportable activity performed on behalf of Sovereign Military Hospitaller Order of St. John of Jerusalem of Rhodes and of Malta during this reporting period.

**15. The Federal Republic of Nigeria**

There was no reportable activity performed on behalf of the Federal Republic of Nigeria during this reporting period.

**16. The Government of the State of Qatar**

During the reporting period, Patton Boggs advised the Government of the State of Qatar in regard to its bilateral relationship with the United States, its trade and commerce activities, and legal matters involving the Embassy of the State of Qatar and Qatari nationals. Patton Boggs also rendered advice to the Embassy concerning its charitable activities in the United States; the exercise of diplomatic functions, including consular visits to, and communications with, Qatari nationals detained in the United States; interpretation of obligations established by treaty; issues of diplomatic immunity; and civil litigation involving Embassy personnel.

**17. The Royal Embassy of Saudi Arabia/Qorvis Communications**

Registrant counseled the foreign principal on United States legislative and executive branch developments affecting the bilateral relations of the U.S. and Saudi Arabia as well as multi-lateral issues in the Middle East and Gulf regions.
