As requested by the foreign principal, the Registrant will render advice on matters involving bilateral relations between the United States and Venezuela, including legal analysis, counsel and strategy development, as well as policy advocacy before officials and staff of the legislative and executive branches of the U.S. Government regarding any legislative, regulatory and public policy activities affecting the interests of the Government of the Bolivarian Republic of Venezuela. To perform these services effectively, the Registrant may select, approve and engage, as required, other qualified providers of professional services—in such fields as professional strategic communications, public relations, etc.—to assist and support the Registrant. In performing these services, the Registrant may coordinate with the Government of the Bolivarian Republic of Venezuela (including the Ministry of Foreign Affairs), its agencies and instrumentalities, as well as with corporations and other organizations in Venezuela whose interests may be impacted.
