



Dear Mrs. Myers,

We confirm with thanks receipt of your letter of October 25, 1972, marked NM/gmc, as well as of the enclosed ordering list.

It was a pleasure to learn that in the future you wish to deal on a larger scale - beside scientific books - also with the books of Corvina Press published on applied arts a.s.o.

Unfortunately, we are not in a position to grant you a trade discount of 70% as you have been informed already. However, on the basis of our negotiations with Corvina Press and in order to facilitate the widening of our relations with your est. House we are ready to grant you a discount of 60% on the price of the books of the said publisher. We do hope that we shall now soon receive your final order.

In order to help you to make a success of the distribution of the books on applied art, i.e. that you be able to include also retail shops in this distribution, we accept your setting the price of these publications /originally \$ 1,75/ in \$ 2,-, as a unit price of the volumes belonging to this series. /We shall charge you with \$ 1,75/volume less 60% discount/. - After checking our stock we stated that of the volumes you required we could supply you with the following:
