Re: Pending Legislation re World War II-Related Claims

Dear Ms. Motherby and Ms. Luebben:

This will confirm that we have opened a separate billing number relating to potential meetings with members of the U.S. Congress and/or U.S. government agencies on potential legislation regarding World War II-related issues and bringing that legislation into harmony with existing U.S. Executive Agreements with foreign nations and U.S. law. This matter will be subject to the general terms of our pre-existing engagement and Deutsche Bahn's applicable billing guidelines. The billing rates for the principal attorneys who would work on this matter are Owen C. Pell (Partner – US \$832/hour) and Karen Asner (Partner – US \$720/hour).

For purposes of budgeting, we estimate that this matter may entail fees of up to \$35,000, with an understanding that we may revisit this estimated cap if the scope of the engagement changes significantly. We estimate that out-of-pocket costs and expenses associated with this matter to be reimbursed by Deutsche Bahn under its current internal invoicing guidelines, which have been provided to us, should be less than \$5,000.

We very much appreciate the opportunity to handle this additional matter for Deutsche Bahn.




