

Registrant will also represent Falconbridge Limited and its subsidiary, Falconbridge International Limited, with respect to certain limitations imposed by the United States Government on the importation of certain metal products.

Registrant's representation of Falconbridge in connection with the foregoing matters may include discussion of the issues and Falconbridge's position with appropriate U.S. agencies, legislators and other officials, as well as the press and other persons with an interest in the matter, including agencies and officials of the Governments of Canada and the Dominican Republic.


