The registrant has continued to represent Middle East Airlines and Kuwait Airlines before the Department of Transportation in connection with certain applications, authorizations, permits and exemptions, including, without limitation, representation of Middle East Airlines in proceedings concerning revocation of its authority to operate in the United States.

During the reporting period, the registrant rendered advice and counselling to Alitalia concerning certain international aviation matters, including ongoing bilateral negotiations between the United States and Italian governments. In addition, the registrant performed legal services on behalf of Alitalia in connection with certain administrative proceedings before the Department of Transportation and certain judicial proceedings pending before United States courts.

During the period May 12, 1986 through June 7, 1986 the registrant rendered advice and counselling to Fiat S.p.A. in connection with (1) legislation pending in the U.S. Congress that would affect contracts between U.S. Government agencies and firms affiliated with certain unfriendly governments; (2) legislation proposed in the U.S. Congress that would deter the Department of Defense from finalizing an equipment supply contract awarded to a subsidiary of Fiat S.p.A.; and (3) discussions with the Department of Defense concerning the disposition of such equipment supply contract. In addition, the registrant represented Fiat S.p.A. in connection with the foregoing three matters before certain Members of Congress, their staffs and the Department of Defense, all as detailed in the response to question #12.

The registrant rendered advice and counselling to Alitalia concerning the promotion of Alitalia's commercial interests in connection with certain bilateral negotiations between the United States and Italian governments on aviation matters. During the reporting period the registrant had several conversations with staff personnel of the Department of Transportation and Department of State, which were confined to obtaining procedural information concerning the scheduling of pending bilateral aviation discussions and other information concerning existing U.S. Government interpretations and policies. The registrant also accompanied the Chairman of Alitalia, Dr. Nordio, on a courtesy visit with Deputy Secretary of State Whitehead; and the registrant met with the Washington Office of the State of Georgia to obtain information concerning the visit of a Georgia business delegation to Rome.

On behalf of Fiat S.p.A., the registrant had discussions with officials and staff of the Department of Defense, including Secretary of Defense Caspar Weinberger, H. Lawrence Garrett, III, General Counsel, Office of Secretary of Defense, and Fred C. Ikle, Under Secretary of Defense Policy, Department of Defense; staff of the Senate Armed Services Committee; and members of the press. The purpose of these communications was to urge the rejection of legislative provisions that would adversely impact on the Department of Defense's award of an earthmoving equipment supply contract to Fiat's North American subsidiary.

The registrant also contacted and/or met with the above-named officials of the Department of Defense and their staff personnel to discuss arrangements with respect to the use of revenues to be paid to Fiat's subsidiary for the performance of the above-mentioned contract.

During the reporting period, the registrant did not engage in any political activities on behalf of other foreign principals.




