The registrant has continued to represent Middle East Airlines and Kuwait Airways before the Department of Transportation in connection with certain applications, authorizations, permits and exemptions.

The registrant has also continued to advise Alitalia concerning international aviation matters, including regulatory and bilateral matters outstanding between the United States and Italian governments.

The registrant has advised Falconbridge Limited in connection with various legal matters related to the ferronickel operations of Falconbridge Dominicana in the Dominican Republic. In addition, the registrant represented Falconbridge Limited and Falconbridge International Limited in proceedings before the Office of Foreign Assets Control, Department of the Treasury with respect to the importation into the United States of certain metal products.

The registrant has advised the Government of Malaysia in connection with potential state and federal food labelling requirements, and potential proceedings before the Federal Trade Commission ("FTC") and the federal courts regarding health claims made about palm oil. In this regard, registrant has communicated with entities making health claims, with government officials (including congressional staffers, and personnel from the FTC, Department of State and Food and Drug Administration) and with public relations entities.
