The registrant has continued to represent Middle East Airlines and Kuwait Airways before the Department of Transportation in connection with certain applications, authorizations, permits and exemptions. On behalf of Kuwait Airways, it also has provided representation before the Treasury Department's Office of Foreign Assets Control ("OFAC") with respect to certain licenses under regulations adopted in August 1990.

The registrant also has continued to advise Alitalia concerning aviation matters, including routine commercial matters and regulatory and bilateral issues outstanding between the United States and Italian governments.

The registrant has advised Falconbridge International regarding the certification agreement entered into between the United States and the Soviet Union with respect to the importation into the U.S. of certain metal products. It also has represented Falconbridge International before OFAC with respect to implementation of the requirements of such certification agreement.

The registrant has advised the Government of Malaysia and the Malaysian Palm Oil Promotion Council in connection with potential state and federal food labeling requirements and other routine legal matters.
