

The agreement between the registrant and foreign principal calls for the registrant to render general public relations services to the foreign principal for the purpose of attracting increased tourism to Grenada. In furtherance of this objective, registrant will conduct a public relations campaign in which it will approach travel agents, media people and special interest groups and distribute information concerning Grenada. Furthermore, registrant will arrange trips to Grenada for media people and travel agents. Registrant will also arrange meetings between Grenada Department of Tourism personnel and U.S. media personalities and travel agents.

5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

Registrant shall prepare and distribute materials containing information regarding travel to and tours of Grenada. Registrant shall work closely with the Grenada Department of Tourism in an effort to attract tourists to the island. In furtherance of this, registrant shall conduct a media campaign and shall meet with media persons and travel agents to promote Grenada as a tour destination.
