



¹Political activity as defined in Section 1(o) of the Act means the dissemination of political propaganda and any other activity which the person engaging therein believes will, or which he intends to, prevail upon, indoctrinate, convert, induce, persuade, or in any other way influence any agency or official of the Government of the United States or any section of the public within the United States with reference to formulating, adopting, or changing the domestic or foreign policies of the United States or with reference to the political or public interests, policies, or relations of a government of a foreign country or a foreign political party.

AGREEMENT

By this Agreement entered into between Black, Manafort, Stone & Kelly Public Affairs, Inc., (hereafter Consultants), and UNITA, the Parties agree as follows:

1. **Scope of Employment.** Consultants will provide general professional services to UNITA related to representation in Washington.

2. **Term.** This Agreement will cover the period from January 1, 1995 to June 1, 1995.

3. **Fees.** In return for the performance of the service outlined herein, UNITA agrees to compensate the Consultant in the amount of \$15,000 per month plus expenses. Monthly payment shall be due on the first of each month. Expenses shall be billed at the end of each month and be due upon receipt.
