

Dear Ambassador Mekouar:


It is Edelman's policy to document in contractual form the terms under which it accepts client assignments so there will be no misunderstandings at a later date. Recognizing, however, that final agreement on the contract can be delayed for various reasons, we ask you or another authorized representative of the Embassy of the Kingdom of Morocco to sign this interim letter authorizing us to commence work on your behalf.

This authorization to commence work applies solely to services we would perform related to this week's upcoming parliamentary elections, as summarized in the accompanying cover letter of this same date. Per the accompanying cover letter, we will bill an all-inclusive fee of \$5,000 (five-thousand dollars) for the services to be performed. Alternatively, should the Kingdom of Morocco enter into a longer-term services agreement with Edelman on or before the end of this calendar year, we will be pleased to incorporate this fee into the first month's retainer (or hourly fees plus expenses) called for under that agreement.


