Edelman Imageland LLC, hereinafter referred to as **Executor**, represented by Director General Veronika Moiseeva acting on the basis of Charter, and **OJSC Russian Venture Company**, hereinafter referred to as **Customer**, represented by Director General I.R. Agamirzyan, acting on the basis of the Charter, hereinafter referred to as Parties, have concluded the present Appendix No 5 to Contract No 12-10 RIK MS dated April 30, 2010 as follows:

1. On the instructions of Customer, Executor shall provide the following services throughout the period from September 6, 2010 to October 22, 2010 in the framework of preparation and organization of a visit of the U.S. venture fund delegation, Global Innovation Partnerships (hereinafter referred to as Event):

1.1. Preparation of text materials

- 1.1.1. Development of 5 (five) official press releases for the Event (announcing, follow-up) in Russian and English, texts approval and improvement.
- 1.1.2. Preparation of press kits for the media events on October 6 and October 11 (6 (six) text materials totaling up to 12 pages) in Russian and English.
- 1.1.3. Development, editing, translation of text materials of the official newsletter and official website (totaling up to 100 pages).
- 1.1.4. Drafting circular notes, official welcome addresses and technical assignments (totaling up to 12 pages).

1.2. Interaction with the U.S. media and press offices

- 1.2.1. Interaction with the Press Office of California Governor Arnold Schwarzenegger.
- 1.2.2. Development of English versions of information materials and press releases for the Western media, mailout of press releases to the Western media.

1.3. Press tour of journalists, including foreign media, to Tatarstan

- 1.3.1. Development of the list of journalists (up to 30)
- 1.3.2. Inviting journalists
- 1.3.3. Accreditation
- 1.3.4. Collection of passport details (up to 15)
- 1.3.5. Preliminary individual interaction with journalists
- 1.3.6. Development and mailing additional materials

1.4. Development and execution of a special event program for the Delegation members

- 1.4.1. Arranging a walking tour in the Kremlin on October 11, with an English-speaking guide.
- 1.4.2. Arranging a visit and excursion at the Tretyakov Gallery on October 11.
- 1.4.3. Arranging a visit and excursion at Alexander Puskin's Museum on October 12.
- 1.4.4. Arranging and holding sightseeing tours by request for some of the delegates (planning, facilitating meetings, reservation, provision of a guide, holding a 2-day event program).
- 1.4.5. Photographing the delegate's excursion at the Kremlin.

1.5. Obtaining a special permission for video recording for TV crews:

- 1.5.1. To follow the delegation during the excursion at the Kremlin on October 11.
- 1.5.2. To video record the official reception dinner at the Tretyakov gallery.

1.6. Administrative support of the Event

- 1.6.1. Development of the list of the Event participants and production of badges (not more than 750 names).
- 1.6.2. Registration of the event participants, hand-out of badges
- 1.6.3. Transportation of the Customer's mobile stands (3 sets of 3 items each)

- for Article 5 – 59,000 roubles, including VAT 18% - 9 000 roubles
- for Article 6 - 53,100,000 roubles, including VAT 18% - 8 100 roubles
