Pursuant to the Letter of Appointment ("Agreement") by and between 100 Lives Ltd. ("Client") and Daniel J. Edelman, Inc., doing business as Edelman ("Consultancy") dated September 1, 2014, this Scope of Work is incorporated into and subject to the terms and conditions of the Agreement.

DESCRIPTION OF PROFESSIONAL SERVICES

Consultancy will perform public relations activities in the United States to promote, position, launch and manage the National Commemoration of the Armenian Genocide Centennial (NCAGC) in Washington, DC, a project linked to the 100 LIVES Foundation. Activities will include, but are not limited to, media relations, invitee expansion, event support, supporting content creation, editorial support, stakeholder engagement, and strategic counsel.

Basis for Compensation. At the end of each month, Consultancy shall invoice Client the exact fees based upon the hours incurred in performing the Services during that month.
