


5. Describe fully the activities the registrant engages in or proposes to engage in on behalf of the above foreign principal.

The registrant will represent the interests of the Government of Cyprus before the Legislative Executive Branch of the United States Government. This representation will include the preparation and dissemination of political progaganda, as defined by the Act, meetings and telephone conversations with Members of Congress and their staff and Members of the Administration and their staff. Registrant will participate in strategy and coordination of sessions with the foreign principal.
