For SONANGOL, Ltd., the state-owned petroleum corporation in Angola, which operates in all aspects of the international petroleum market.

Primary activities relate to trade and investment promotion, and in assisting the Angolan government generally, and SONANGOL specifically, to undertake better means to formulate and explain their general economic policies, and their foreign investment laws and policies. Continued studies and planning concerning the eventual possibility of opening a trading office for SONANGOL.

Other activities consisted of assistance in coordination and strategy planning by Angolan officials as described in previous supplemental statements, namely analysis of current and prospective public images and policy viewpoints of Angola in the U.S.A., and assistance in the selection/hiring of other firms/individuals.

¹The term "foreign principal" includes, in addition to those defined in section 1(b) of the Act, an individual or organization any of whose activities are directly or indirectly supervised, directed, controlled, financed, or subsidized in whole or in major part by a foreign government, foreign political party, foreign organization or foreign individual. (See Rule 100(a)(9)).

On my own behalf, and as a long-time Africanist and businessman, there are several general activities related primarily to Africa generally, and also to Angola specifically, in which I am engaged. These include an active membership and participation in such professional organizations as the African Studies Association, and the Association of Political Risk Analysts.


