Japan's Emergency Package of Economic Measures

The Japanese government has recently announced an emergency package of economic measures for the purpose of further stimulating its domestic economy, expanding imports, and increasing Japan's assistance program to developing nations. A supplementary budget for the economic package is to be submitted to an extraordinary session of the Diet, Japan's parliament, in early July.

Japanese Prime Minister Yasuhiro (Yah-soo-her-o) Nakasone (Na-ka-so-nay) made clear his government's determination to carry out the new economic measures as pledged during recent talks with President Reagan in early May.

To stimulate domestic demand the Japanese government has decided to adopt fiscal measures amounting to an unprecedented \$43 billion, or 1.8 percent of Japan's Gross National Product, \$36 billion for extra public investments, and a \$7 billion tax cut as part of Japan's tax reform.

To encourage imports the Japanese plan to allocate \$1 billion of the supplementary budget for government procurement from overseas, including purchase of airplanes, helicopters, and supercomputers. It is also improving import procedures and lowering interest rates of the Export-Import Bank of Japan for the import of manufactured goods from abroad.

And finally, in order to contribute to the international community, Japan has decided to double its Official Development Aid (ODA) to developing nations in five (5) years, instead of seven (7) years as planned, and more than \$7 billion will be disbursed in 1990. Further, more than \$20 billion in new and completely untied public and private funds will be recycled to those countries over the next three (3) years. In addition to these two measures, grants will be increased with respect to Sub-Saharan African and other Least Developed Countries (LDC) including the provision of non-project-type grant assistance in the order of \$500 million over the next three (3) years.

Chief Cabinet Secretary Masaharu (Moss-su-ha-ra) Gotoda (Go-to-dah) said, "We expect that these large-scale measures will bring about a drastic expansion of Japan's domestic demand. We also believe that the measures will contribute to the steady correction of trade imbalances, strengthened economic growth, and the stable development of the world economy."

THE 1987 JAPAN EXCHANGE AND TEACHING PROGRAM

This week marks the final call by the Japanese ministries of Foreign Affairs, Education, and Home Affairs to send 500 American college graduates to live and work in Japan for a one-year period. The positions will be as English language instructors or as coordinators of international exchange activities in Japan. The program, the Japan Exchange and Teaching (JET) Program was initiated by Japan to promote mutual understanding between Japan and participating countries.

The program will involve hiring of 500 Americans, who will be "JETted" to Japan in late July 1987, where most will work teaching English, preparing teaching materials, and making oral presentations at schools. In addition to transportation costs, successful applicants will receive a salary of about \$23,000 for the year, working Japan's 5 1/2 day work week.

Japan is hoping that a successful first year will allow it to expand the program up to 1000 American college graduates, giving a much needed boost to their English language education and internationalization.

To qualify, applicants must be Americans holding a bachelor's degree (by August 1987), have an excellent command of English, be interested in adapting to life in Japan, and have excellent health. Applicants should have a high level of commitment and motivation, a knowledge of or a desire to learn the Japanese language, and an interest in education and teaching in Japan.

Interested applicants should contact the Embassy of Japan, Office of the JET Program, or one of the regional Japanese Consulates for further information and application forms. The deadline for receipt of applications is February 10, 1987.
