

INSTRUCTIONS: A registrant must furnish as an Exhibit B copies of each written agreement and the terms and conditions of each oral agreement with his foreign principal, including all modifications of such agreements, or, where no contract exists, a full statement of all the circumstances by reason of which the registrant is acting as an agent of a foreign principal. One original and two legible photocopies of this form shall be filed for each foreign principal named in the registration statement and must be signed by or on behalf of the registrant.

Privacy Act Statement. Every registration statement, short form registration statement, supplemental statement, exhibit, amendment, copy of informational materials or other document or information filed with the Attorney General under this Act is a public record open to public examination, inspection and copying during the posted business hours of the Registration Unit in Washington, D.C. One copy of every such document, other than informational materials, is automatically provided to the Secretary of State pursuant to Section 6(b) of the Act, and copies of any and all documents are routinely made available to other agencies, departments and Congress pursuant to Section 6(c) of the Act. The Attorney General also transmits a semi-annual report to Congress on the Administration of the Act which lists the names of all agents registered under the Act and the foreign principals they represent. This report is available to the public. Finally, the Attorney General intends, at the earliest possible opportunity, to make these public documents available on the Internet on the Department of Justice World Wide Web site.

The North West Development Agency (NWDA) is a new institution formed from the merger of a number of existing organizations, one of which was INWARD. The headquarters of the NWDA are located in Warrington, North West England. While the name of INWARD is no longer in use in England, the name has been retained for the U.S. office based in Evanston, IL.

Although there is no formal written agreement or exchange of correspondence in place between INWARD in Evanston and the NWDA in Warrington, the functions (see question 8 below) and funding of the Evanston operation remain as before. All costs of the Evanston operation are met by bank transfer of funds from the NWDA into INWARD's Bank One Account.


