<sup>1</sup>Political activity as defined in Section 1(o) of the Act means the dissemination of political propaganda and any other activity which the person engaging therein believes will, or which he intends to, prevail upon, indoctrinate, convert, induce, persuade, or in any other way influence any agency or official of the Government of the United States or any section of the public within the United States with reference to formulating, adopting, or changing the domestic or foreign policies of the United States or with reference to the political or public interests, policies, or relations of a government of a foreign country or a foreign political party.

RETAINER AGREEMENT

THIS AGREEMENT is made between the Government of the Republic of Guatemala (the Government) and the Individual, Bruce P. Cameron (the Individual).

(1) The Government and the Individual have agreed that the Individual shall provide legislative and related services to assist the Government, working with the Embassy of the Government in the United States, excepting military assistance and police related matters.

(2) In carrying out the above mentioned services, the Individual will work under the direction of and report directly to the Ambassador of Guatemala to the United States.

(3) The Government will compensate the Individual at the rate of \$3,000.00 per month; and in addition will reimburse him for necessary expenditures. The monthly fee will be paid on the 30th day of each month of the contract period. The expenditures shall be reimbursed pursuant to detailed statements of expenditures furnished by the Individual.

(4) This Agreement shall commence on July, first 1987. It may be terminated at any time by either party on written notice.

(5) In connection with his representation, it is understood that the Individual, in certain circumstances, may be required, under applicable United States Law, to register his representation of the Government, and that the Individual and his staff will comply with all requirements of United States Law in this connection.
