RGIT's primary publication is the weekly online newsletter "Washington News", which reaches a substantial audience. While "Washington News" is primarily intended for a German audience, occasionally articles appearing in the publication are translated into English and posted to registrant's website.

RGIT occasionally submits public comments in response to draft rules, etc. published by the federal government, and also tracks legal developments of interest to German industry, filing amicus curiae, or friend-of-the-court briefs from time to time.


