RGIT arranged for meetings in March 2012 between Stefan Mair and Bernhard Welschke of the BDI with Messrs. Chris Wilson and Jim Sanford, both assistant United States Trade Representatives, for the purpose of discussing trade matters. During this visit to Washington, Messrs. Mair and Welschke also met with Geoffrey Antell, Majority Counsel, Iji Rangaswami, Minority Staff Director, and Behnaz Kibria, Minority Counsel to the House Ways and Means Committee Subcommittee on Trade.

RGIT also arranged for meetings between the chief executive of the BDI, Hans-Peter Keitel, and Senator Joseph Lieberman and Charles Collyns, Assistant Secretary for International Finance at the U.S. Department of the Treasury. These meetings took place in mid-July.


