During the current reporting period, registrant served as a facilitator of contacts between registrant's principals DIHK and BDI and various like-minded interests in Washington, including domestic industry associations, non-governmental organizations in Washington, and various branches of the federal government. On September 19, 2012, registrant arranged a meeting between a senior BDI executive and Mr. Geoffrey Antell, Trade Counsel to the House Ways & Means Committee to discuss trade matters including a prospective transatlantic free trade agreement. On October 23, 2012, registrant hosted a workshop on patent harmonization which featured a keynote speech by Under Secretary of Commerce David Kappos and in which Assistant United States Trade Representative Stanford McCoy participated as a panelist.

RGIT's primary publication, the weekly electronic newsletter "Washington News", tracks current topics of interest to the transatlantic business community. Although RGIT does not deem the following as "political activity", RGIT does from time to time submit comments in response to requests for comments issued by the federal government, and has on occasion submitted amicus curiae briefs to the courts in connection with matters deemed to be of critical importance to maintaining free and fair trade.
