RGIT employees planned visits for members of the Federation of German Industry (BDI) to meet with members of Congress and their staff, as well as officials of the Department of Commerce, the U.S. Trade Representative (USTR) and the Department of Labor. The purpose of these visits was to prepare, and later follow-up, for the Hannover Messe trade fair in April 2016, where the United States was the official partner country. The meetings were used to exchange ideas and contacts.
